The project will include tear off and haul away of existing roof and installing of new commercial panel 24 gauge.

**AGREEMENT FOR
PUBLIC WORKS BUILDING ROOF REPLACEMENT**

THIS AGREEMENT, made and entered into this _____ day of _____, 20____, by and between the CITY OF SHREWSBURY, (hereinafter referred to as "City") and

_____, a Missouri corporation, (hereinafter referred to as "Contractor").

WHEREAS, City is the owner of the Public Works building roof located at 7309 Melbourne Ave., Shrewsbury, Missouri 63119 (hereinafter referred to as "Roof Replacement")

WHEREAS, the City has solicited proposals for replacing the roof of the Public Works building, after evaluation of all relevant data has determined to award the Contract to Contractor,

NOW THEREFORE, in consideration of the mutual promises and covenants herein contained, it is hereby agreed by and between the parties as follows:

The Contractor shall perform all required work and shall provide and furnish all permits, labor, materials, necessary tools, equipment, and services to complete the roof replacement, in strict compliance with the Contract Documents. It is understood and agreed that said labor, materials, tools, equipment, and service shall be furnished; and said work performed and completed under the direction and supervision and subject to the approval of the Owner or its authorized representative.

The Contractor further agrees that he is fully informed regarding all of the conditions affecting the work to be done, and labor and materials to be furnished for the completion of this Contract; and that his information was secured by personal investigation and research and not from any estimates of the Owner; and that he will make no claim against the Owner by reason of estimates, tests, or representation of any officer, agent, or employees of the Owner.

The Contractor expressly warrants that he has employed no third person to solicit or obtain this Contract in his behalf, or to cause or procure the same to be obtained upon compensation in any way contingent, in whole or in part, upon such procurement; and that he has not paid, or promised, or agreed to pay to any third person in connection therewith, any brokerage, commission, or percentage upon the amount receivable by him hereunder; and that he has not, in estimating the Contract Price

demanded by him, included any sum by reason of any such brokerage, commission, or percentage; and that all moneys payable to him hereunder are free from obligation of any other person for services rendered, or supposed to have been rendered, in the procurement of this Contract. He further agrees that any breach of this warranty shall constitute adequate cause for the annulment of this Contract by the Owner, and that the Owner may retain to its own use from any sums due or to become due hereunder an amount equal to any brokerage, commission, or percentage so paid, or agreed to be paid.
